# **GSDI III and CoLTEK launch Joint Cooperation in Festive Ceremony**

## Accra, Ghana, 4th April, 2019:

The Ghana Skills Development Initiative (GSDI III) and the College of Technology Education (CoLTEK) of the University of Education, Winneba (UEW), situated on the Kumasi campus, officially launched their cooperation on April 4th, 2019 in a festive ceremony which included the presentation and signing of a Memorandum of Understanding (MoU) and the establishment of a joint working group. The working group will focus on the development of teaching material and a manual for in-service CBT-facilitation training.

CoLTEK is currently the only institution training TVET teachers at the university level. TVET teachers are being trained in both theoretical and practical aspects of occupations and are qualified after graduation to train TVET students at the second cycle level (i.e. technical institutes). GSDI III, in turn, is providing capacity development for facilitators (teachers) and management staff of TVET training providers. In order to explore options on how to institutionally anchor this support to TVET teachers in the Ghanaian system and, thus, to ensure alignment and sustainability, GSDI and CoLTEK established contact and deepened cooperation through the signing of the MoU. GSDI III aims at supporting TVET teacher training focused on school management and competency-based training (CBT). The cooperation agreement will assign CoLTEK to implement state-of-the-art teacher training all over Ghana.

Various partners and stakeholders affiliated with the TVET sector participated in the event by addressing the more than 50 dignitaries, guests and participants. During his welcome address the Chair of the meeting, Rev. Fr. Prof. Anthony Afull-Broni, Vice Chancellor of UEW, stated his pride of hosting the important event which marks the official beginning of the cooperation with GSDI. The principal of CoLTEK, Prof. Fredrick Kweku Sarfo, then highlighted the role of CoLTEK in the future development of schooling and teaching standards in the TVET sector. Dr. Fred K. Asamoah, Executive Director of the Council for Technical and Vocational Educational Training (COTVET) pointed out the importance that TVET takes on the agenda of the Government of Ghana. He quoted the State of the Nation Address given by H.E. the President of the Republic of Ghana, in which he announced the establishment of 10 state-of-the-art TVET centres in 2019. The importance of the high-standard skills training was also supported by Mr. Daniel Lauchenauer, Deputy Head of Cooperation, Embassy of Switzerland in Ghana. In order to reach the highest possible level of skills, employability and competitiveness in Ghana, the training of teachers is key, he said. He also underlined the importance that TVET has to meet the demand of the private sector and therefore encourages cooperation between the private sector and training providers.

After representatives of GSDI III presented their contribution to skills development in Ghana in 6 Ghanaian regions and with more than 100 training providers and 20 different trade associations (representing 8 trades), the MoU between GSDI III and CoLTEK was officially In cooperation with:



introduced and signed. As defined in the MoU, GSDI and CoLTEK intend to jointly carry out the following activities for capacity development at training providers (TP): 1. Adapt and develop a manual for in-service CBT-delivery training for facilitators, 2. Train master trainers for in-service CBT-delivery training for facilitators, 3. Update in-service school management training manual, 4. Train master trainers for in-service school management training.

After the official part of the event had ended, the newly established working group between GSDI III and CoLTEK had their first working session while invited guests and dignitaries toured the CoLTEK facilities including the CBT Center.

### **About Ghana Skills Development Initiative**

The Ghana Skills Development Initiative (GSDI) III is a project commissioned by the German Federal Ministry for Economic Cooperation and Development under the Programme for Sustainable Economic Development (PSED) and co-funded by the European Union (EU) under the Ghana Employment and Social Programme (GESP) and the Swiss State Secretariat for Economic Affairs (SECO) under its Ghana Private Sector Competitiveness Program (GPSCP). It is implemented by the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH in cooperation with the Council for Technical and Vocational Education and Training (COTVET) and other public and private stakeholders. Its current phase (GSDI III) started in April 2016 and is planned to run until September 2019.

GSDI supports COTVET's innovative approach to introduce competency-based training (CBT) standards and collaborative training models which combine both workplace-based training and school-based training modules at selected TVET providers. The project particularly seeks to improve the quality of the traditional apprenticeship system and enhance skills and qualifications. It has been working in eight trade areas (electronics, garment making, welding, cosmetology, automotive, electrical installation, furniture works, and block laying + tiling) and six regions (Greater Accra, Volta, Northern, Ashanti, Western, and Eastern). Furthermore, GSDI III develops demand-oriented TVET offers for the agricultural sector (ATVET) along three selected agricultural value chains (cashew, mango, oil palm).

### **About German Cooperation**

Germany has been an important and reliable partner for Ghana since its independence in 1957. The goal of the German-Ghanaian development cooperation is to consolidate Ghana's status as a lower middle-income country by promoting sustainable, poverty-oriented, and inclusive economic growth.

Development Cooperation between Ghana and Germany has a long and trustful tradition. Since the start of bilateral relations with Ghana in 1957, Germany has allocated over EUR 1.5 billion to sustainable development in the country. From 2015 to 2017, bilateral support for Ghana amounts to EUR 241.1 million. Against the background of Ghana's status as a "lower middle income country" and in line with the priorities of the Ghanaian government, the German bilateral development cooperation focuses on the following four priorities: Good Governance, Agriculture, Sustainable Economic Development, and Renewable Energy. In the sector of Sustainable Economic Development, German Cooperation is supporting Ghana through the Programme for Sustainable Economic Development (PSED) with an actual budget of EUR 26.6 million. The German support to TVET in Ghana also encompasses the Ghana TVET Voucher Program (GTVP) amounting to EUR 10 million.

German-Ghanaian Technical Cooperation projects are mostly implemented by GIZ, whilst projects of Financial Cooperation are implemented by the KfW Development Bank. Germany also contributes approx. 21 % to the EU budget.
